4. Competition track:

The competition track is for all categories and classes uniform. The competition track is circuit which is defined by four buoys in the length of 1500 m.

5. Rules

U.I.M. rules (Blue and White Pages) and the program.

The organizer and race directorate retain the right to announce additional rules and regulations specifically for the races mentioned in this program. These rules and regulations must be in conformity with the rules and regulations of the U.I.M. and are obligatory as any other rules and regulations of these races. Drivers must be informed about these additional rules and regulations by the race commissioner during the official drivers' briefings.

7. Accomodation

9.Prizes

The driver placed on the 1st to 5th placed in the international races will be Awarded with material prizes including 2 mechanics.

10.Travel costs and fees

As per the relevant UIM rules for each class of F500, F250, F125

For drivers participating in more than 1 category out of the 2, starting fee will be provided as per UIM Rule 108.02, counting as 1 entry.

12. Organization of the Races:

The boats and drivers must be at the jetty two minutes before the start. Three mechanics shall be permitted per driver. The engines can warm up two minutes to 30 seconds before the start. All engines have to be turned off 30 seconds before the start. Drivers that turn on will be disqualified. At the end of the 30 seconds the red light is switched on. The race will be started when the red light is switched off, within 5 to a maximum 12 seconds. Drivers who start their engine or leave the jetty while the red light is on shall be penalized with the deduction of 1 lap. The race shall be finished after the first boat crosses the finish line. All following Drivers still in the race shall be flagged down and assified according to their position in the race. Drivers who wasn't start within 5 minutes after the starting run signal must leave the JETTY start.

13. Race length for each category and class:

F500 3 heats – 8 laps

F250 3 heats – 8 laps

F250 3 heats – 8 laps

FR1000 4 heats – 8 laps

14. Verification of boat

Verification of boat hulls and engines of the first tree drivers participating in the World and European Championship will be compulsory within the scope set by the U.I.M. rules. The verification will be placed in a closed boat park. Boats must remain without any changes see rule 321.01. U.I.M.

15. Insurance:

All drivers must have a valid insurance policy for personal and material injury of the third party, incl. drivers.

This insurance can't be settled and fee paid at the competition.

16. Presentation:

Each driver is obliged to present himself in the office of the competition and to submit the following documents for the year 2013:

- a) Valid race's license for the year 2013
- b) Certificate of the boat measurement 2013
- c) Certificate of the medical examination valid for 2013
- d) Certificate of the payment of insurance against the personal injury or material damage to the third party 2013

Documents can't be substituted by any declaration and without these documents, the start will not be allowed.

17. Race stopped

In the case of an accident or of the health of race participants is in danger, the heat shall be immediately stopped. After the course is cleared, the heat is once repeated. Safety boats has absolute right to way. During the stoppage the refueling is allowed at the boats on the bank and not allowed to boats at water.

18. Medical examination

The medical officer has the right to submit any driver (or mechanic) entered to a psychophysical examination and this at any time during the event, an alcohol test may be performed. The result of such examination is immediately communicated to the jury who basing themselves on the report of the medical officer, may exclude the driver from the competition. There is no appeal against this decision.

19. Exceptions:

The organizer has the right to stop or interrupt the race individual heats, all races or to reduce the number of heats due to force majeure or with regard to the safety of the race, resp. time program.

20. Liability:

The organizer – IMRAMOVSKY MARINE s.r.o. – is not liable to the drivers, mechanics or other participants for the material damages or personal injury arose from the international competition. Drivers and their company will take part in the race at their own danger and risk. By signing the registration form they are waiving all claims on the remedy of the damage caused in connection with the international competition in Roudnice nad Labem, against organizers – IMRAMOVSKY MARINE s.r.o. – their members, commissioners, racers and other participants of this international competition.

21. Pit Area

Starting of the engines on the shore is possible only without a propeller or with a cover. Each driver must have own vessel for emptying the oil. Emptying the oil down on the ground will be punished by disqualification for the whole competition. Every driver must have an absorbent carpet under the motor.

22. Protests:

Protest against such circumstances which can be known to the drivers before race opening should be applied not later than during the drivers meeting. Other protest shall be handed only in writing not later than 30 minutes after the posting of result with the protest fee 2000,- CZK. Protest against time measurement are not possible. In case of protest concerning engines, the protesting party bears eventual costs of the assembly up to the deposit of 1.000,- CZK. The protest will be judged only by the Jury. The protest must be submitted in writing in Czech or English.

23. Penalties:

- failing to use the absorbent carpet 5.000,- CZK
- failing to comply with the instruction of the starting commissioners on the jetty start 500,- CZK
- emptying the oil on the ground 5.000,- CZK and disqualification
- drivers that will not be on the Drivers briefing will pay a penalty of 2000,- CZK
- destruction of the course turn buoy 5.000,- CZK

24. International Jury

The leaders of the groups from individual countries must have a written authorization from their National Authorities, both for the membership in Jury, in compliance with the U.I.M. rules.
